## DESCRIPTIVE REPORT

to accompany Topographic Sheet No. 3817

When the weather was unsuitable for triangulation observing a party from the Str. YUKON made a topographic survey of Sweater Bay, the first bay Northwest of Cape Ikti.

LIMITS: The finished topography covers the interior of the bay to an outlying rock off Cape Ikti, about a half mile South of O Cairn, which is located on the boulder spit. That part of the shore on the West entrance to the bay, shown as sketched (dashed) was located by intersecting on prominent shore objects from two set-ups but the base was very short.

CONTROL & METHOD: When the topography was done triangulation had not been completed in this vicinity but the signals were built. A projection was not used but triangulation signals were cut in and later the work was swung on a projection. As a whole the work is a traverse but a fix was used occassionally. Contours were located from vertical angles on hill tops and prominent marks on the hills. A scale of 1:20,000 was used.

GENERAL DESCRIPTION: The country surrounding the bay is very precipitous, the lower elevations being covered in thick alder and the higher are bare rock. The shoreline is rocky but appears to drop off suddenly and no outlying rocks were seen. The anchorage shown was used by the YUKON and afforded protection in any weather, sandy bottom. The bay as a whole is deep. The South entrance to the bay is marked by a boulder spit.

REMARKS: The outlying rock off Cape Ikti,1/2 mile South of Ocairn marks the last rod reading and would be a suitable place to take up work. O Cabrn is also a convenient beginning point.

NAME: This bay was known as Sweater Bay by the YUKON party as there was not a local name for it.
