DESCRIPTIVE REPORT TO ACCOMPANY TOPOGRAPHIC SHEET NO4 LIMITS:

This sheet extends from north latitude 58 17 to 58 10 and from west longitude 134 26 to 134 52. It was made to complete the form line work on Admiralty Island and to run a portion of the form lines on Douglas Island. The previous work done is shown in blackaink, the part finished this year is in red. After this section of form lines was run I found that the Geological Survey had made a very complete survey of that side of the passage therefore I determined to concentrate my efforts on the Admiralty Island side. The weather conditions at this part of the season were unfavorable for form line work, many days shore line work was carried on when low hanging clouds made it impossible to see the mountain tops. The work already done on this sheet will be useful in transferring the work done by the Geological Survey.

I would recommende that this sheet be returned to the field next season as it will save making another one for this area. It also has all the data on it , necessary to tieing in with the previous work.

- 1. The records conform to the requirements of the General Instructions.
- 2. This survey, as far as made, conforms to the requirements of the General Instructions, except that it has only about one-half the specified number of determined elevations.
- 3. The descriptive report states that weather conditions did not permit doing the proposed work on the Admiralty Island portion of the sheet. It also states that the work was discontinued on Doublas Island because the surveyor learned that the Geological Survey had recently contoured the island.

The Geological Survey stated in September, 1924, that they had done no surveying in the locality of this sheet, and Capt. Heck's information, therefore, is erroneous. There are no form lines by either the Geological or Coast Survey on the southern and western shores of Douglas Island.

The form lines remain to be done on Admiralty Island from the southwest bight of Young Bay to Horse Island. When this is done the gap in the shoreline between T. 3681 and T. 3848 should be supplied. At the same time the head of Hawk Inlet should be surveyed if possible.
