Descriptive Report to accompany sheet covering revision of topography in the vicinity of Pt. Arenas, vieques Id., Porto Rico.

/

This sheet contains topography in the vicinity of Pt. Arenas, vieques Id., Porto Rico, and shows the changes in topography at that point. The solid black line shows the shore line as it now exists; and the former position is shown by broken line. Pt. Arenas has built out to the northwest and eroded back due to the influence of the dock at Pt. Arenas Landing. This fact is well established by the undermined palm trees now at the water's edge.

A^A short traverse was run along the southern shore starting from Arenas & to locate signals for the use of wire-drag survey. This traverse was tied into the wells shown on the former survey and was not closed between triangulation points.
