Limits:

This sheet is on a scale of 1:10,000, and covers the topography of Pyramid Cove, San Clemente Island, off the California Coast. The work was done simply to locate signals for control of hydrographic work in this section.

Ensign Herschel B. Brown made a plane-table survey of the place during January, 1925, but at that time hydrographic work was not taken up. During April, 1926, this vessel, then under my command, was in that section and the survey was started. I considered it advisable to have the signals located by an officer of greater experience, so Lieutenant G. C. Jones was detailed for this duty.

The traverse was controlled by triangulation signals and presents no unusual difficulties or features. A heavy surf was continually breaking on the beach, which interfered considerably with the progress of the party.
