#### LOCALITY :

The topography executed on this sheet consists of the shoreline bordering Gunston Cove, Fairfax County, Virginia (An Arm of the Potomac River), and its approaches. It does not include the extremities of Pohick and Accotink Bays, two small bays at the head of Gunston Cove.

#### CONTROL:

The control consists of Third Order Triangulation established by this party. The traingulation stations occur at frequent intervals (about one-half to one and one-half statute miles apart).

#### PERSONNEL:-

The topography on this sheet was done by four Deck Off-icers, Mr. H. O. Westby, Mr. C. Le Fever, Mr. L. P. Sowles, and

Mr. R. L. Tellman, attached to the party for training, and with some field supervision and Illustrative work by Mr. L. C. Wilder, Jr. H. & G. E.

#### METHODS:

The shoreline was surveyed principally by the traverse method altho three-point fixes and plane-table triangulation were exemplified.

All traverses concluded with negligible errors, except a traverse from O DOG to  $\Delta$  LIGHT, which had a closing error of about 20 meters in azimuth, and 10 meters in distance. This error was adjusted by the usual methods. Plane-table triangulation was extended in Pohick Bay from Stations POHICK and ACCO to Signals DIP and FIF.

#### PURPOSES:

The purpose of this sheet was (a) to locate intermediate signals for detailed revision hydrography, (b) to test the permanency of the shoreline as compared with the date of the original survey, (c) to afford each of the Junior Officers attached to the party at the time some practical experience in plane-table work, and methods.

#### GENERAL OBSERVATIONS:

Due to limited time available, the survey did not include as much detail adjacent to the shoreline, as was desirable (locations of

buildings, roads, etc.).

The wharves at OOLD, OFER, OOUT, OUP, and near A GUNSTON are dilapidated and unfit for use as wharves.

Comparisons of this survey with photostats of the original survey appears to indicate that there was a lack of adequate control for large scale reproduction in the interior of the cove at the time of the original survey.

The rodding was all done by the above mentioned Junior Officers.
