DATE OF INSTRUCTIONS - Work on this sheet was executed under instructions dated Nov. 2, 1933.

SCOPE OF SHEET- The purpose of this sheet was to furnish control for photo-compilation sheets, to locate and re-mark (when necessary) stations of other bureaus, to locate navigational ranges, aids to navigation, natural objects for landmarks, to locate signals for hydrography, and to locate and permanently mark topographic stations to serve as control in future surveys in the area.

CHARACTER OF CONTROL - Control was furnished by triangulation established in 1933.

SURVEYING METHODS - Stations were located by graphic triangulation.
