PROJECT: Ph-1 (45) DATE OF INSTRUCTIONS: 7Dec45; Sup. 1,
28Dec45; Sup. 2, 5Jan46; Sup. 3, 31 Jan46

DATE OF FIELD WORK: March 18 to March 22, 1946

PURPOSE: To locate on the sheet existing aids to navigation and make major topographic revisions where necessary in the original shore line and topographic detail.

FIELD WORK: The field work consisting of additions and corrections to the original survey have been shown on the sheet in orange ink to distinguish them from the original work. Only these corrections and additions are discussed in this report.

AIDS TO NAVIGATION: All aids to navigation were located by 3 or more planetable cuts, with the exception of Bayou St. John West Beacon 3. Two planetable cuts were taken. One check angle was taken at Bayou St. John Entrance Lt. from Perdido Pass Range Rear Bn. to Bayou St. John West Bn. 3 to B.P. 6. Another was taken at Bayou St. John West Bn. 3 from Perdido Pass Range Rear Bn. to Bayou St. John Entrance Lt. These angles are recorded in Field Observations, Vol. 15, page 2.

MAJOR TOPOGRAPHIC CHANGES: The only major topographic changes on this sheet are the widening of the canal connecting Big Lagoon and Old River, and Perdido Entrance covered by Photos. 2936, 2937, 2930 and 2931. Aerial Photos. 2936 to 2939, 2930 to 2933 and 2923 to 2928 fall within the area of these sheets.

LANDMARKS, GEOGRAPHIC NAMES, COAST PILOT CORRECTIONS, RECOVERY OF HORIZONTAL CONTROL, MAJOR TOPOGRAPHIC CHANGES, HYDROGRAPHIC INFORMATION, FIELD INSPECTION OF PHOTOGRAPHS, and DISCREPANCIES IN PUBLISHED BRIDGE DATA have been made the subject of a special report and is submitted by areas for this project.
