FIELD REPORT

SHORELINE MANUSCRIPT

SURVEY NO. T-8914

For Field data covering Survey No. T-8914 refer to the special Field Report L 81, 1947, Gulf Intracoastal Waterway, Vermilion Bay, Louisiana, to Port Arthur, Texas, submitted by Ross A. Gilmore, dated October 1947, filed in the Nautical Chart Branch.

COMPILATION REPORT

SHORELINE MANUSCRIPT

SURVEY NO. T-8914

This manuscript is one of a series of shoreline surveys in Project No. PH-14(46), located along the Intracoastal Waterway and covering a narrow strip of land from Houma, Louisiana to Corpus Christi Bay, Texas. This project was undertaken to furnish the necessary data to prepare a new series of Inland Waterway Charts at 1:40,000 scale.

Compilation instructions were not prepared.

26. CONTROL

This manuscript was received from the Washington Office with the control plotted thereon. A list of these stations on Form No. M-2388-12 is included in this report.

27. RADIAL PLOT

The radial plot for this survey was made in the Washington Office. Refer to the radial plot report contained in the descriptive report for Survey No. T-8910.

28. DELINEATION

Limits of areas of marsh, high ground and the interpretation of other inland features were determined after careful stereoscopic examination of the photographs.

The field inspection of shoreline and offshore features was adequate for the area of this survey.

30. MEAN HIGH WATER LINE

The mean tide range in the area covered by this manuscript is about one foot thereby making the MHWL and MLWL for all practical purposes one and the same.

The shoreline was delineated after careful stereoscopic examination.

31. MEAN LOW WATER LINE

See mean high water line.

32. DETAILS OFFSHORE: FROM THE MEAN HIGH WATER LINE

A number of oil wells, derricks and pilings in Mermentau Lake were indicated by the field party and were radially plotted on this manuscript.

33. WHARVES AND SHORELINE STRUCTURES

Delineated in accordance with field identification.

34. LANDMARKS AND AIDS TO NAVIGATION

Thirteen nonfloating aids in the area of this survey were identified by the field party. Eight of these could be identified on two photographs and were radially plotted. They are as follows:

The remaining five were visible only on photograph: 18599 and their positions were plotted as follows:

A straight line was drawn on photograph 18599 from Amerada Fipe Line Day Beacon 18 thru Day Beacons 16, 14, 12, 10, 8, 6, 4,2 and extended until it intersected a structure on piles just southwesterly of the day beacons.

A point on this structure where it was intersected by the extended line was identified on two photographs and plotted. A line was drawn on the manuscript through this position and Day Beacon 12. Photograph 18599 was then oriented under the manuscript and radials were drawn through Amerada Pipe Line Day Beacons 2; 4, 6, 8, and 10. The intersection of these radials with the previously drawn line are the positions plotted on the manuscript for Day Beacons 2, 4, 6, 8, and 10.

44. COMPARISON WITH EXISTING TOPOGRAPHIC QUADRANGLES

Survey No. T-8914 has been compared in detail with U.S. Geological Survey, Grand Lake East, Louisiana quadrangle (NW) and found to be in fair agreement except for the following:

Flat Prairie Island on the east and west side of Ridge Canal and also a point of land approximately 300 meters southeast of Flat Prairie Island have been shown as marsh in accordance with field inspection.

In the marsh south of Bird Island at approximately lat. 29° 55' 17", long. 92° 42' 40", a canal has been dug 230 meters southerly.

45. COMPARISON WITH NAUTICAL CHART

Due to the great difference in scale between this manuscript at 1:10,000 and Nautical Chart No. 1051 at 1:175,000, a minute comparison could not be made.

The following topographic information shown on Survey No. T-8914 is of sufficient importance to warrant immediate application to the chart:
